Alameda County Community Food Bank

Alameda County Community Food Bank has been in business since 1985 ... with a vision toward a day when they can go out of business. ACCFB is the hub of a vast collection and distribution network that provides food for 240 nonprofit agencies in Alameda County.



In 2015, the Food Bank distributed 25 million meals -- more than half of the food was fresh fruits and vegetables. Their goal is to ensure every food insecure child, adult and senior in Alameda County knows where their next meal is coming from, by 2018.

Through the network of 240 strategically placed member agencies (food pantries, soup kitchens, child-care centers, senior centers, after-school programs and other community-based organizations) as well as their own direct-distribution programs, the Food Bank distributes enough food to provide 540,000 meals weekly.

Their systematic approach to alleviating hunger includes:

A multilingual outreach effort which serves as the blueprint for programs across the nation

Dynamic hunger and nutrition education programs

An innovative advocacy program that promotes policies to benefit low-income residents.

A Culture of Service

There are many types of service--sexual, domestic, and commercial—to name a few. But for me, ACLC is built around community service.

What is "community service", anyway?

To me, community service means contributing one's resources (time, money, effort) to one's community for many reasons.

I choose to perform my service with ACLC to contribute back to Alameda County, because that's where my paycheck has come from for the last 15 years. The company I work for is headquartered in Fremont, and many of my clients are in Alameda County.

In gratitude for providing me with the means to pay for a roof over my head and food on the table, I donate time, money, and effort towards ACLC, so that I'm not just sucking money out of the community without giving something back.

For the last three years, my community service has been to serve on ACLC's Board of Directors. This is my preferred method of disseminating a Culture of Service: leading by example.

What is the Culture of Service?

The Culture (some might say cult) of Service, however, is very much an Old Guard concept, yet it still applies today to the leather community in general, and ACLC in specific.

In the Culture of Service, one contributes to try and repay the debt of having a community to belong to.

Sometimes, this means paying a personal debt forward, performing a service for others because at some point in the past, someone has performed a service for or assisted you.

In the Old Guard (before my time, despite some people's thinking I must be more than old enough to have been around then), one "earned one's leathers" by performing service to another individual or group until one had perform sufficient service for a sufficient amount of time that the community deemed that person worthy of being recognized as a full member of the group.

While this concept started off as sexual service, it evolved to mean general domestic service, personal service, and eventually community service.

Why participate in the Culture of Service?

In the Culture of Service, one performs service for the benefit of others. In Judaism, there is a similar concept called "making a mitzvah", in which one performs a service for others without expectation of recompense or even recognition.

Why perform a mitzvah, then? I hear you cry, What's in it for me?

Because in Jewish Ethics, *making a mitzvah improves the condition of the entire world just a little bit*, in one specific place. If you're a science fiction fan, think of making a mitzvah as doing one's part to reduce entropy in your little corner of the universe.

If just one person makes a mitzvah/performs a service, the world's condition is improved a tiny amount...but what happens when *two* people make a mitzvah?

How about six people?

How about 60 people?

The more people who join in, the more the beneficial effect begins to ripple outwards to the community, the region, the nation, the world.

ACLC and the Culture of Service

ACLC provides many service opportunities throughout the year (in fact, multiple opportunities per month). We talk about these opportunities at General Assemblies, at events, at parties, in every Committee or Board meeting, in email, on Facebook, and on our Website.

I am saddened to observe that many of the newer members in our community (and a few of the older members) don't seem to be, well, *getting the hint* that their services are needed.

Oh, they may attend an *occasional* General Assembly or go to an *occasional* ACLC fundraising event, but they're not helping to run the club, work on committees, or stage events.

In short: they're not *contributing*. (And I don't mean financially; I mean in terms of *service*.)

And here's where I believe the mental disconnect comes in

- ACLC is not a "belonging to" club whose logo one wears on one's vest to brag of the
 affiliation.
- ACLC is a "hands-on" club whose members are expected to pitch in for every event they possibly can, to assist in raising money to help those most in need in Alameda County.

Look around you at the next ACLC meeting or event, and ask yourself, What has each of these folks done for ACLC over the past six months? What have I done for ACLC over the past six months?

Consequences of Failure

Right now, the Board of Directors is trying to gauge if we have enough members who will volunteer to help with SF Pride, Folsom, and Dore Alley beverage booths this year. The income from those booth operations pays for the club's overhead expenses.

If we drop the booths, that will mean as much as 30% of our annual income (perhaps more) will need to go to pay for the costs of running ACLC rather than being donated to our beneficiaries.

Over the last five years, booth participation has declined rapidly, resulting in a smaller number of people trying to do all the work that 25 to 30 people used to do every year. Folks, 6 or 7 people can't sustain these booths. We need the entire club—all 60+ of us! —to pitch in for every single booth, every single year.

It's that, or watch the Corps shut down for lack of service participation, because we won't be able to sustain our own overhead costs.

Similarly, over the last decade, there's been a shift from the Board guiding the Club in service opportunities to the Board working themselves to exhaustion for the Club because members aren't pitching in to work on committees, run events, or work in beverage booths.

Rebuilding the Culture of Service

So how do we go about rebuilding our Culture of Service? If you have any ideas, please approach me or any other Board member; we'll be happy to listen.
